#### PROCEDURE FOR PAYMENT OF FEE WITH DID UP FAMILY

Starting from the didUP Family update 1.12.0, parents can proceed with the payment of the fee using the PAYMENTS function.

A specific payment event will be created for the amount to be paid (ADVANCE and/or BALANCE).

By downloading the payment notice, it will be possible to produce a file containing the payment data. The document can be printed and can be used for payment at a betting shop or at a bank counter. You can also proceed via the App-IO, by reading the QRCode, or via Home Banking, entering the following data: Notice code, Entity code, Amount and Cbill.

By clicking on Pay, and choosing "Continue here", you will automatically find all the available payments selected.
